FROM THE VILLAGE PRESIDENT...
Dear Park Ridge Residents,

On November 8th I attended the United Way's "Life Report" presentation. Every five years the United Way puts together the "Life Report" to identify community strengths, challenges, and priorities. This year's keynote speaker was Tom Mosgaller who identified factors for a healthy community: Among them were awareness, relationships, safety, and economic stability. He emphasized the importance of being connected to your neighbors.

I agree with Tom. Knowing our neighbors is vital to having a healthy community. He challenged everyone to imagine a tic tac toe game around your house with your home being the center of the nine squares. Then see if you can name everyone in the eight squares around you. If you give this a try and find that you can name all eight of your neighbors call me at 715-342-6986 because I have a holiday treat for you! In the colder months it's easy to disconnect from our neighbors. I challenge each of you this holiday season take time to visit with your neighbors and maybe trade a plate of Christmas cookies.

Speaking of the holidays, once again Santa will be making visits to all the homes with young children the evening of December 18th. Santa's favorite elf, Gert Neuendorf, will be coordinating visits. Be sure to call her to get your children's names on the list.

Lastly, here's some important Village business – at the November 20th meeting of the Board of Trustees we voted to adopt a five-year road improvement plan. We also voted to do a traffic count, get a professional pavement rating and apply for a Road Improvement grant to help offset the cost of repaving. We then applied for that grant and on Monday, November 27th, we learned that we were awarded \$11,000 to offset those reconstruction costs. We can apply for this same grant again in 2019.

Our comprehensive planning committee recommended that Linwood Avenue be the first street to be repaved. Linwood has more cracks in the pavement than any other street in the Village. Fieldcrest and Hillcrest are next in line. We anticipate repaving, replacing the street lights, and putting in drainage swales. It is anticipated that the repaving will increase taxes approximately \$30 to \$40 on a \$100,000 home.

We also recognized that the Village is out of compliance with our assessments. The State requires we reassess every home every ten years. In 2018 B.A. Pauls will again make their way to every house in the Village.

Our 2018 budget was passed unanimously, with only about a \$700 increase in Village administration. Our total budget is \$220,806 with \$181,404 coming from property taxes. Our mill rate remains at 3.80, as it was last year. Once again, we have managed to provide services and quality of life at minimal taxation.

This holiday season I challenge you to meet your new neighbors, stay connected with your old neighbors, and treasure this wonderful little burg of Park Ridge that we all call home. I wish you and your family the very best this holiday season.

NOTICE TO PROPERTY OWNERS AND RESIDENTS VILLAGE OF PARK RIDGE SNOW AND ICE REMOVAL

Pursuant to Village Ordinance 8.05, Snow and Ice Removal, all sidewalks must be cleared of snow and ice within twenty-four (24) hours after snow ceases to fall. If this is not done, the Village shall remove the snow and/or sand any ice present and the cost shall be billed to the property owner. If not paid within thirty (30) days, said delinquent charge shall be included in the current or next tax roll as a special charge for current services, as provided for in Wisconsin State Statutes § 66.0907(5).

WINTER-TIME REMINDERS

- 1. Snow sticks are the owner's responsibility and should be placed no closer than 1' to the pavement's edge.
- 2. Please do not park on the street when 3" or more of snow is expected.
- 3. Please trim branches that may sag under the weight of snow and obstruct stop signs or pose a hazard to school buses or snowplows.
- 4. Sand/salt mixes is available behind the Village Hall—bring a container. Free to residents.
- 5. Snowplow damage to mailboxes: save your receipts. T&C Services will reimburse the cost of materials ONLY. Maximum \$75.
