#### Roster:

Finished Q2 with 18 on roster. Two were released due to lack of attendance after multiple contacts.

100% of staff, all 18, have at least minimum technical school level, state-required, training completed to operate on the fire-ground. Several are waiting for State certification exams, and more advanced training.

### **Equipment:**

As mentioned above one SCBA failed required annual service testing. We are now down 2 units as another failed in 2018. Used units cost \$1900 each. We have two of the same vintage (old) units still in service. This may be a purchase made at end of 2019, and again early in 2020, budget dependent (2 each year, would allow 4 to be the same make/model, close to the newer units currently in service).

All vehicles need to go in for DOT inspections.

Some hose remains to be tested.
